

MINUTES OF THE COMMISSION MEETING HELD JANUARY 14, 2020

INVOICE PAYMENT

Motion-That the Commission approves payment of the 2020 E-ZPass Interagency Group's (IAG) annual assessment for our participation in the IAG, in the amount of \$75,000.00-was made by Commissioner Wozniak, seconded by Commissioner Deon, and approved unanimously.



AGREEMENTS

Motion-That the Commission approves the negotiation and execution of the Agreements and an Amendment for the items listed in memos "a" through "j":

- a. Amendment to our agreement with Info-Matrix Corporation for project management and business analysis work order services, exercising the option to renew the agreement for an additional two-years; at a not-to-exceed amount of \$2,500,000.00 for the two-year period;
- b. Settlement Agreement and authorize the appropriate Commission officials to execute all necessary documents in the case, PTC v. Huertas, Cowan Systems, and Cowman Equipment, LLC;
- c. Agreement with Crops Market LLC for the distribution of E-ZPass Go Packs at its stores;
- d. Supplemental Reimbursement Agreement with West Penn Power Company (WPP) for utility relocation for construction of the Southern Beltway, Section 55B, for an increase of \$6,506.76 due to higher labor costs for WPP to sub contract out its work to expedite the relocations to meet project deadlines; for a revised not-to-exceed amount of \$31,506.76;
- e. Supplemental Reimbursement Agreement with West Penn Power Company (WPP) for utility relocation for construction of the Southern Beltway, Section 55C2-2, for an increase of \$67,470.31 due to higher labor costs for WPP to sub contract out its work to expedite the relocations to meet project deadlines; for a revised not-to-exceed amount of \$169,298.84;
- f. Reimbursement Agreement with Robinson Township to reimburse the Township the cost for its review and inspection fees to take over the Ft. Cherry Connector on the Southern Beltway; at a not-to-exceed amount of \$99,280.00;
- g. Temporary Construction Easement Agreement with Chapman Commerce Center, LLC (Chapman) to permit Chapman to enter the Southern Beltway limited access right-of-way for the purposes of excavating, grading and other construction activities on its property adjacent to the Findlay Connector; Chapman will reimburse the Commission the cost for the required maintenance and protection of traffic on the Southern Beltway;
- h. Settlement Agreement and Release with Christopher Lawrence; and authorize payment of the workers' compensation settled amount;

- i. Agreement with Land Reclamation Group, LLC to supply the stream and wetland mitigation credits required for the total reconstruction project from MP 123.00 to MP 131.00; at a not-to-exceed amount of \$1,115,325.00;
- j. Settlement Agreement and Release with Dick Corp.; and authorize payment of the settled amount in exchange for a full and final release of all claims.

#### RIGHT-OF-WAY REQUEST

Motion-That the Commission approves the Right-of-Way Requests for the items listed in memos "a" through "h":

- a. Acquisition of Right-of-Way #4021-H (The Borough of Middletown), a partial take parcel necessary for reconstruction of Bridge EB-311 (Union Street Bridge) by authorizing payment of \$500.00 representing fair market value to The Borough of Middletown; authorize appropriate Commission officials to execute the Temporary Construction Easement and other documents that may be required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of an executed Temporary Construction Easement as approved by the Legal Department;
- b. Acquisition of Right-of-Way #4020-C (Middletown Area School District), a partial take parcel necessary for reconstruction of Bridge EB-311 (Union Street Bridge) by authorizing payment of \$900.00 representing fair market value to Middletown Area School District; authorize appropriate Commission officials to execute the Right of Entry Agreement and other documents that may be required; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of an executed Right of Entry Agreement as approved by the Legal Department;
- c. Acquisition of Right-of-Way #14S274 (Bruce Jackel), a total take parcel necessary for construction of the Mon/Fayette Expressway, Rt. 51 to I-376, by authorizing payment of \$247,657.64 representing fair market value, pro-rated taxes and recording fees to Universal Settlement Service of Pennsylvania, LLC, escrow agent; also authorize payment of \$29,325.30 representing replacement housing supplement and closing costs to Bruce Jackel; authorize the appropriate Commission officials to execute the Agreement of Sale and other documents that may be required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of a deed as prepared by the Legal Department;

- d. Settlement of Right-of-Way #17638 (Alan R. & Carolyn R. Rank), a partial take parcel necessary for construction of the Southern Beltway, US 22 to I-79, by authorizing payment of \$7,500.00 for water well claim to Alan R. and Carolyn R. Rank; authorize the appropriate Commission officials to execute the First Amendment to Settlement Agreement and General Release as approved by the Legal Department; and payment of the settlement funds is contingent upon Condemnees' delivery of an executed First Amendment to Settlement Agreement and General Release;
- e. Settlement of Right-of-Way #17389 (James A. & Diane L. Bednar), a partial take parcel necessary for construction of the Southern Beltway, US 22 to I-79, by authorizing payment of \$39,400.00 representing settlement to James A. and Diane L. Bednar; authorize the appropriate Commission officials to execute the Settlement Agreement and General Release, as approved by the Legal Department; authorize payment of Section 710 damages up to \$4,000.00 as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of the settlement funds to the Condemnees is contingent upon the delivery of an executed Settlement Agreement and General Release, as approved by the Legal Department;
- f. Acquisition of Right-of-Way #14S039 (Pittsburgh & West Virginia Railroad, operated by Wheeling & Lake Erie Railroad Company), a partial take parcel necessary for construction of the Mon/Fayette Expressway, Rt. 51 to I-376, by authorizing payment of \$500.00 representing fair market value to Wheeling & Lake Erie Railroad Company; authorize the appropriate Commission officials to execute the documents required for closing; authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of a Deed of Highway Easement as prepared by the Legal Department;
- g. Approve plans entitled, "Drawings for Establishing and Reestablishing Limited Access Highway and Authorizing Acquisition of Right-of-Way for Contract No. T-028.45T001-4 Roadway and Bridge Reconstruction for Pennsylvania Turnpike SR 0076, Milepost 28.49 to Milepost 30.88, from STA 30+24.03 to STA 83+76.01", as prepared and approved by the Engineering Department;
- h. Adopt the proposed Property Acquisition Resolution for Right-of-Way #14S649 (Frank & Cynthia L. Lee), a total take parcel necessary for construction of the Mon/Fayette Expressway, Rt. 51 to I-376, by authorizing payment of \$3,000.00 representing estimated just compensation to counsel to be named at a later date; and authorize payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel.

Motion-That the Commission approves the Award of Contract #A-120.40R002-3-02 for bituminous resurfacing between MP A120.40 and MP A128.05, to the lowest responsive and responsible bidder, New Enterprise Stone & Lime Co., Inc.; at a not-to-exceed amount of \$20,386,000.00 and a contingency of \$1,000,000.00-was made by Commissioner Wozniak, seconded by Commissioner Deon, and passed unanimously.
