SUPPLEMENT

Motion-That the Commission approves the negotiation and execution of Supplemental Agreement #2 for Contract #T-186.20S004-2 with Gannett Fleming, Inc. for design services for the rehabilitation of the Tuscarora Tunnel, for an additional \$250,000.00 to complete the final design tasks and perform roadway reconstruction design and operating system design; for a revised not-to-exceed amount of \$4,500,000.00 -was made by Commissioner Drew, seconded by Commissioner Richards, and passed unanimously.

- c. Reimbursement Agreement with West Penn Power (WPP) to reimburse WPP the cost for the engineering and facility relocation work necessary for the replacement of Bridge WB-500 at MP 59.58; at a not-to-exceed amount of \$65,957.33;

Grant of Perpetual Easement and Right-of-Way to PA Dept. of Environmental Protection (PA DEP) for construction, use, operation, inspection, maintenance, repair, rehabilitation, improvement and replacement of improvements and other flood protection activities necessary for the flood protection project the DEP is undertaken in Luzerne County adjacent to MP A117.92 to MP A118.15.
